

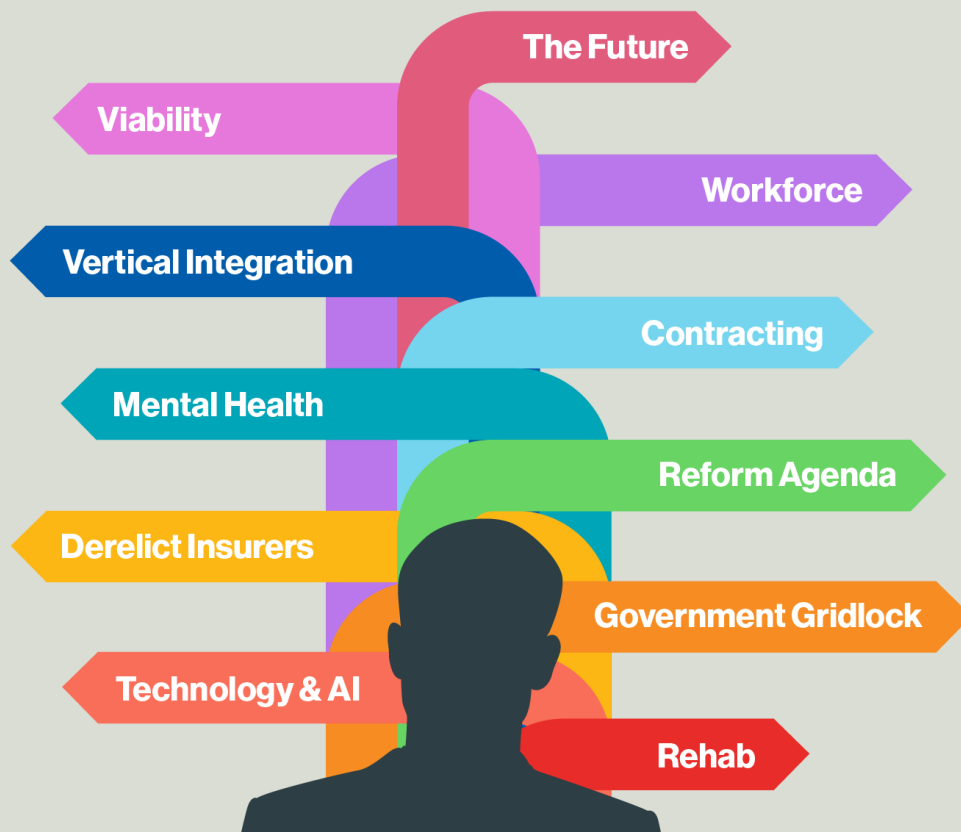

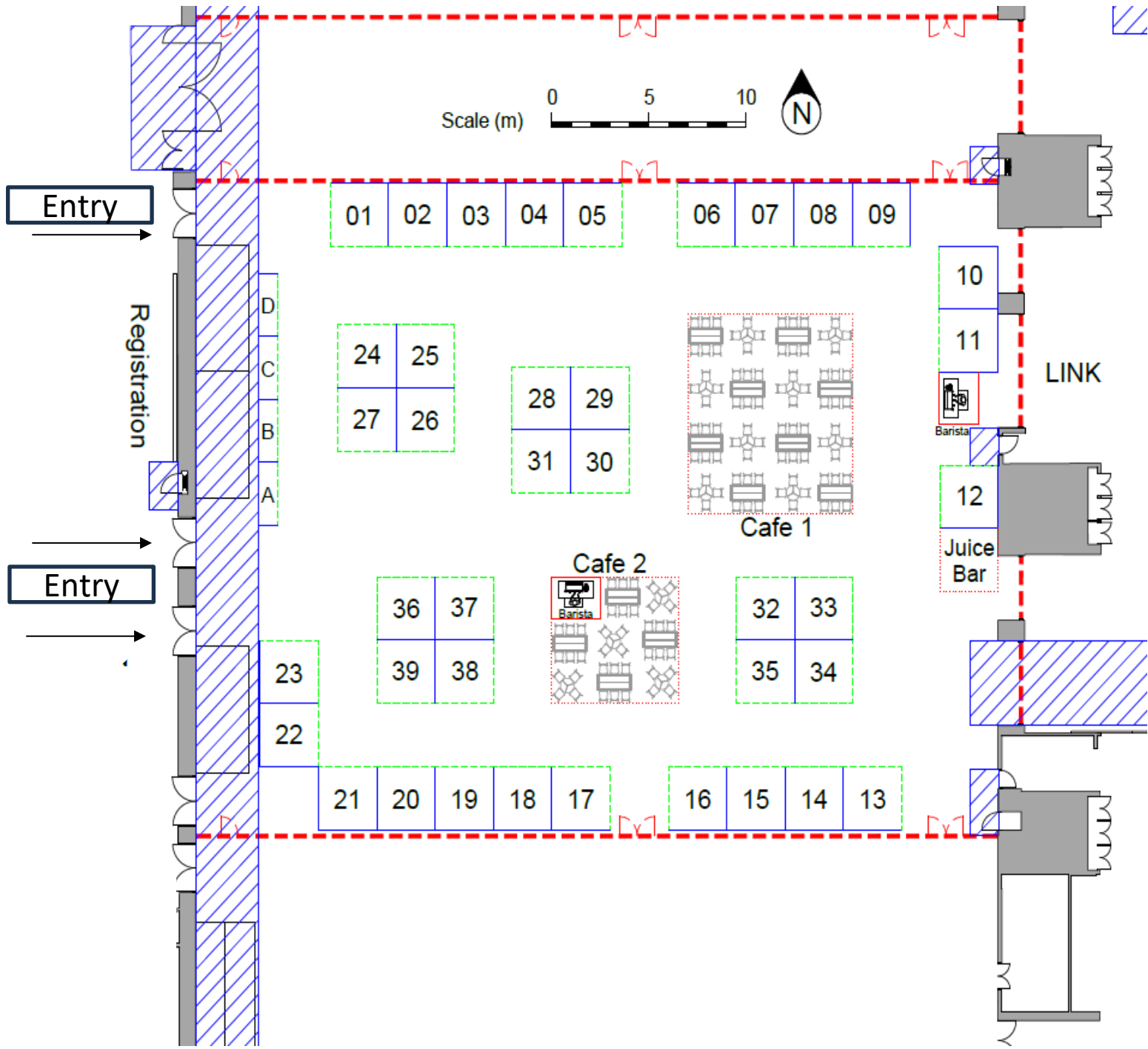

Terms and Conditions

Sponsor agreement

1. Where appropriate, Goods and Services Tax (GST) is applicable to all goods and services offered by Australian Private Hospitals Association (APHA) and all prices in this document are inclusive of GST. GST is calculated at the date of publication of this document. APHA reserves the right to vary the quoted prices in accordance with any movements in the legislated rate of the GST.
2. All applications for exhibition and/or sponsorship are subject to approval by APHA at its sole discretion.
3. Exhibition space and sponsorship will be allocated only on receipt of a signed Exhibitor and/ or Sponsor Agreement Form and payment of the required 50 percent deposit. Preferred exhibition space allocation is subject to availability on a “first come, first served” basis and change at the sole discretion of APHA. APHA will provide confirmation of receipt of the booking request via email together with a tax invoice for the required 50 percent deposit. The deposit is payable 14 days from the date of the tax invoice. The balance is due and payable by Thursday 26 March 2026. Applications received after Thursday 26 March 2026 must include full payment.
4. All monies are payable in Australian dollars.
5. If full payment is not received by the due date APHA reserves the right to cancel the booking. Fees for a booking cancelled under this clause will be calculated in accordance with clause 9f and 9g of this agreement.
6. All monies due and payable must be received prior to the event. No organisation will be listed as an exhibitor and/or sponsor in any official event material, and no exhibitor will be allowed to commence move-in operations, until full payment, a completed and signed Exhibitor and/ or Sponsor Agreement Form and, if applicable, the exhibitor’s public and product liability certificate of currency, has been received.
7. If exhibition or sponsorship payment is not received by Thursday 26 March 2026 you will receive an email notifying you that the authorised credit card supplied on the Exhibitor and/or Sponsor Agreement Form will be charged for the remaining unpaid amount.
8. Public and product liability insurance to a minimum of AU\$20 million must be taken out by each exhibitor at their own expense. A copy of the exhibitor’s public and product liability certificate of currency must be submitted at the time of submitting the signed Exhibitor and/ or Sponsor Agreement Form or no later than Thursday 26 March 2026.

9. Cancellation policy

Postponement

- a) If the event is postponed by APHA or the venue, all exhibition and sponsorship bookings will be carried over to the revised event dates.

Cancellation by APHA

- b) If the event is cancelled by APHA or the venue all exhibition and sponsorship payments will be fully refunded subject to deduction of any credit card or bank fees that APHA may incur.

Public health regulations

- c) Should an exhibitor’s and/or sponsor’s attendance to the event be impacted by any restrictions enforced by government regulations, APHA will discuss the available options on a case-by-case basis and come to a mutual agreement with the exhibitor and/or sponsor.
- d) APHA will have no liability to you for costs you incurred with suppliers or contractors associated with this event including, but not limited to, travel, accommodation and/or booth display.

Cancellation by exhibitor and/or sponsor

- e) Notice of cancellation by an exhibitor and/or sponsor must be made in writing to APHA.
 - f) In the event of cancellation by the exhibitor and/or sponsor (other than as a consequence of any restrictions enforced by public health government regulations), the following cancellation fees will apply.
 - i. More than 61 days prior to the event (before Thursday 26 March 2026): 50 percent of the total payment due will be applicable.
 - ii. From 60 days prior to the event (from Friday 27 March 2026): 100 percent of the total payment due will be applicable.
 - g) Should a cancellation be made prior to payment, the appropriate cancellation fee will be applicable, and APHA will issue an invoice which will be payable within seven days.
 - h) No exhibitor and/or sponsor shall assign, sublet or apportion the whole or any part of its exhibition and/or sponsorship package except upon prior written consent of APHA.
 - i) After an exhibitor's space has been accepted, a reduction in exhibition space is considered a cancellation and will be governed by this cancellation policy. Reduction in space may result in relocation of exhibit space at the sole discretion of APHA.
 - j) Any space not claimed and occupied before 5pm, Friday 22 May 2026 may be reassigned without notice or refund.
10. All monies due and payable to APHA may be recovered through any lawful action (including, but not limited to, debt collection processes and/or legal proceedings) instituted by APHA and the exhibitor or sponsor shall be liable for all costs (including, but not limited to, debt collection fees, search fees and/or legal costs on a solicitor and client basis) of instituting and maintaining such action or proceedings and must indemnify APHA for all such costs.
 11. APHA reserves the right to rearrange the floor plan and/or reallocate any exhibit at their sole discretion and without notice. APHA will not discount or refund for any facilities not used or required.
 12. If the exhibitor intends to install a custom-built stand, APHA must be advised, and such advice must include full details and stand dimensions. This information must be received no later than Monday 30 March 2026. All display construction requires the approval of APHA and venue management. A pro-rata fee will apply if any construction occupies space outside the specified space as indicated on the floor plan.
 13. In the use of the exhibition space allocated to you, and at all times in and around the Event premises, you must
 - a) Exercise due care for the persons, property and premises of others and will be solely liable for any harm to any person, or loss of or damage to property or premises you or your personnel cause by any act or omission, whether or not found negligent.
 - b) Not engage in any allegedly unlawful conduct.
 - c) Not use or display any material that is alleged to infringe the intellectual property (including any moral rights) of any other person.
 - d) Limit the offering and distribution of promotional materials to within the immediate vicinity of your allocated exhibition space, except where APHA expressly permits.
 - e) Not include a barista or coffee machine in your allocated exhibition space, unless you are the coffee cart sponsor for the event.
 - f) Not provide device charging stations in your allocated exhibition space, unless you are the wireless charging powerbank sponsor.

- g) Seek approval from APHA for any food and/or beverage offered from your allocated exhibition space to ensure compliance with venue requirements.

APHA reserves the right to terminate your use of the exhibition space allocated to you, without liability to you, and you will be liable for any loss or damage suffered by APHA, if any of these things occur or are threatened by you or your representatives.

14. Exhibitor and sponsorship monies will facilitate the successful planning and promotion of the event in addition to subsidising the cost of management, communication, invited speakers, program and publications. Exhibitor and sponsorship monies are not expended on any entertainment incurred which is incidental to the activities of the event.
15.
